1) CONTRACTS, DEPOSITS, PAYMENTS, CANCELLATIONS

- a) All events require a signed agreement and payment of the required deposit to confirm event.
- b) For subsequent payments, Fort Saskatchewan Golf and Curling Club requires a valid credit card number on file (Visa, or MasterCard).
- c) The credit card number on file MUST be valid through the event date.
- d) Initial deposit and all subsequent payments are non-refundable but may be transferable once received by Fort Saskatchewan Golf and Curling Club
- e) Cancellations of the event must be received via email to the Events Manager and must be received no later than 7 days prior to the event date.

f)	After the event date, Fort Saskatchewan Golf and Curling Club will allow 3 business days for making inquiries regarding your final invoice, and 7 business days to settle any unpaid charges from your event.

2) FC	OOD AND BEVERAGE
a)	Due to licensing requirements by Alberta Health Services and for quality control issues, all food & beverage served on premises must be supplied by Fort Saskatchewan Golf and Curling Club, unless alternate arrangements have been made.
b)	To comply with all health & safety regulations set out by AHS and the AGLC (Alberta Gaming & Liquor Commission), Fort Saskatchewan Golf and Curling Club prohibits the removal of any food or beverage from the premises following an event.
c)	Fort Saskatchewan Golf and Curling Club strictly adheres to all laws and regulations set out by the AGLC.
d)	Liquor sponsorships may be subject to additional fees for the sale and/or service of liquor on premises. Fees will be applied to your final invoice. Fort Saskatchewan Golf and Curling Club will not be responsible for collecting fees from any sponsors, unless alternate arrangements have been made.
e)	Bonspiel attendees shall not bring or consume any liquor on the premises that has not been purchased through Fort Saskatchewan Golf and Curling Club
f)	Fort Saskatchewan Golf and Curling Club reserves the right to end alcohol service at any time if outside alcoholic beverages are being consumed by your attendees on premises; and/or a \$150 fee may be added to your final invoice for each occurrence.

e)	All curlers MUST be wearing appropriate and clean shoes and equipment.
